# 5.3. Special protective actions for fire-fighters

Place in a metal container approved for transportation by appropriate authorities. Clean up residue with an appropriate solvent selected by a qualified and authorized person. Dispose of collected material as soon as possible in accordance with applicable local/regional/national/international regulations.
