5.4. Special protection actions for fire-fighters

appropriate level of protection. Consider the physical and chemical hazards of the material when doing so. 6.2. Environmental precautions

Avoid release to the environment. For larger spills, cover drains and build dikes to prevent entry into sewer systems or bodies of water.

6.3. Methods and material for containment and cleaning up
